Each candidate must have parent responsibility (*) for a registered pupil at the school at the time of the election and must agree to being nominated. Each nomination must be supported by a proposer and seconder, who may be the husband or wife of the candidate. A separate nomination paper must be used for each nomination. Self nomination is not permitted. If there are more candidates than places available, an election will be held. Candidates may, therefore, wish to provide a statement on **not more than one hundred words**, which will be sent to parents with the ballot papers.
